## PRESIDENT'S COLUMN

It's February and "Love is in the Air." We love buying fabrics and love making quilts. How honored we were to have Minnesota Quilters, Inc., 2019 Quilter of the Year, Heather Peterson, for our first guest speaker. She didn't disappoint us with her collection. They were modern and innovative.

I had the pleasure of going on a bus trip with a group from Gruber's Quilt Shop, to the International Quilt Study Center and Museum in Lincoln, Nebraska. They featured antique quilts and duplicated quilts made from reproduction fabrics of Mark Dunn, president and owner of Moda Fabrics in Dallas, Texas. We also saw "Cheddar quilts." Who knew women made quilts from bright gold fabrics in 1870?

### President's Challenge

When you sign in for the meeting in February, you will be asked to randomly choose two color crayons from a bag (no peeking in the bag). You may not exchange the color crayon unless the color crayons are "exactly" the same. If the crayons are two blues, or two greens, and the name on the crayon are not identical, you must use them. No exchanging. The challenge is to make a 24" x 24" wall hanging, with the colors you have chosen. You may add only "one" more color to the quilt – your choice. You have the freedom to choose any block or applique pattern. The quilts should be completed by the September meeting. We would like to include them in the 2019 Quilt Show.

**PROGRAMS****Marjorie LaTour**

The speaker for our February meeting is **Sue Harmon, a quilt appraiser** who has done appraisals for our last two quilt shows. Sue will be presenting, ***“What’s this Old (or New) Thing Worth?”*** How do appraisers come up with a value for my quilt? How do they determine the age of a quilt? Did you know that your brand new quilt that you just completed would probably be replaced for the value of a blanket (\$15-20) by your insurance company without a written appraisal by a certified quilt appraiser? Sue will be using quilts from her collection, which continues to grow, to present examples for her presentation.

Sue Harmon has over forty years’ experience as a quilt teacher, shop owner, lecturer, quilt historian, and appraiser. She is knowledgeable in quilt history, care, restoration and appraisal of quilted textiles, especially those from the turn of the 20<sup>th</sup> century.

Sue began quilting in 1974. After a move to rural Illinois, she was convinced to teach classes and eventually opened a quilt shop. With this began lectures on the history of quilting, dating of fabrics, care and restoration. Sue has taught, lectured and appraised throughout most of the Midwest.

**SERVICE PROJECTS- 2019**

We will have six organizations for Service Projects this year, adding Pathways 4 Youth as a new one:

**Pathways 4 Youth:** Every night there are approximately 150 homeless youth sleeping outside, in cars or couch-hopping with friends in the St. Cloud area. Pathways 4 Youth provides youth experiencing homelessness with the opportunity to learn about and gain access to resources that can put them back on a path that will help them to grow as individuals and be contributing members of our community. Especially needed are fleece blankets or warm quilts.

**Recovery Plus:** Twin size quilts for children aged 12-18, who stay at Recovery Plus for 6-8 weeks. They can take these quilts with them, and often are the first quilt they have owned.

**Pockets of Hope:** Backpacks are given out to children entering foster care, each with a blanket of some sort as well as books, flashlight, toothbrush, etc. The age range is infant to teenager, with a special need for toddler quilts/blankets.

**Stearns Co. Public Health Tummy Time:** Quilts are used with parents and babies for "Tummy Time," playing with babies on the floor, and should be brightly colored and 48" x 48" or larger.

**Eagle's Nest:** Twin-sized bed quilts (approx. 60" x 80") for Veterans staying at Eagle's Nest, a home for Veterans in Sauk Centre. They may take the quilts with them when they leave. Also needed are pillowcases that match the quilts, and items for their silent auction in the fall.

**Coborn's Cancer Center:** Patient bags are given to cancer patients with a variety of personal and comfort items.

As we did last year, we will have occasional speakers from these organizations to give a brief summary of what each organization does. In addition, we will be adding a group sewing day at Gruber's for service projects. The first date will be in March, with the exact date to be decided. The Guild has agreed to provide funds for backing and batting, which will help us produce more quilts and blankets.

At our January meeting, we received 8 quilts for Recovery Plus, 2 quilts for Anna Marie's, 2 quilts/blankets for Pathways4Youth, 1 quilt for Eagle's Nest, 1 quilt for Pockets of Hope, and 50 Coborn's Cancer bags. **THANK YOU FOR YOUR TIME, ENERGY, AND GENEROSITY!!**

The 2019 Mystery Block of the Month Quilt program will begin in March. Sign-ups will be at the February and March meetings. Cost per participant will be \$3 (for the entire year, payable once when you sign up) to cover the usage fee from the designer and the cost of copies. You will receive fabric requirements the first month along with cutting instructions. Months 2-11 will be quick clues for blocks and month 12 will be the assembly instructions. The quilt uses 3 fabrics- light, medium, and dark and can be done in any fabric style of your choice - moderns, florals, reproductions, solids, or whatever. The quilt can be made in lap or twin size (yes! I found one with both sizes!) and you could even make both if you choose.

I am still pursuing the landscape quilt class idea. However the teacher who I had contacted has ghosted me and the guild where I met her, so work continues on finding a suitable replacement. Sorry for the disappointment, but I'll keep working on this.

**Featherweight Group** - This group does fun projects throughout the year. To be part of this group, you must own and bring a Featherweight sewing machine. Julie Johnson is the facilitator. **Board Meeting Minutes – January 3, 2019**

Members present: Sandy Anderson (President), Marie Zaczkowski (Secretary), Karen Cyson (Small Groups), Mary Ann Smith (Treasurer), Ann Hiltner (Co-Treasurer), Marlys Eikmeier (Membership), Elaine Randall (Service Projects), Helen Marion (Service Projects), Maggie Voight (Website/Facebook), Alvina Lieser (Meeting Coordinator)

Meeting was called to order at 6:10 p.m. by President Sandy Anderson. Minutes of the November meeting were approved as published in the newsletter.

**BOARD REPORTS:**

**President** (Sandy Anderson): Election of officers will be held at the January membership meeting. There is a nominee for each board position, except President-elect. Sandy will solicit a nominee for President-elect from the membership.

**Programs** (Sandy Anderson): The speaker for the January meeting will be Heather Peterson of Anka's Treasures. She will present a trunk show of quilts from her designs.

**Treasurer** (Mary Ann Smith): End of December account balances are: Guild checking \$3,907.04; Quilt Show checking \$198.50; CD \$20,164.99; Savings \$4,583.72.

December income from birthday fabric and membership dues was \$671.50. December expense for catering the holiday party was \$534.90.

Total income for 2018 was \$4,816.44. Total expenses for 2018 were \$9,862.91.

Mary Ann presented a proposed budget for 2019. Board members requested some adjustments and Mary Ann will bring a final budget to the next board meeting.

**Meeting Coordinator** (Alvina Lieser): A motion was approved to discontinue having the guild provide refreshments for guild meetings except for special events such as the holiday party. This change is needed since the church no longer has space available to store guild refreshments and equipment.

**Library:** Sandy reported that the guild can no longer store the library at the church since there is no space available. Until a final decision is made about the future of the library, Maggie Voight volunteered to store the library books at her home.

**New Business**

A representative from Minnesota Quilters (MQ) contacted the guild about having a joint meeting with MQ and SCHQ members in St. Cloud. The MN Quilters show will be in St. Cloud in June 2020, and they would like to share quilt show plans with SCHQ members. Marie will contact them for additional information on costs and space needs. Mike Ellingsen was suggested as a possible speaker for the meeting.

**Adjournment:** A motion was approved to adjourn the meeting at 6:50 p.m.
