#### **SCHQ BOARD MINUTES**

#### Ann Chmielewski

The May 7, 2015, SCHQ Board meeting was called to order by President Karen Cyson at 5:45 p.m. at Love of Christ Lutheran Church.

Present: Audrey Abraham, Marlyn Anderson, Ann Chmielewski, Karen Cyson, Deb Danneman, Cindy Kleve, Brooke Strassburg, Sandra Williams, Fawn Wright

**Approval of Minutes:** A motion was made by Sandra and seconded by Cindy to approve the April 2015 minutes as printed in the newsletter. Motion passed.

#### **BOARD REPORTS:**

**Newsletter (Sandra Williams and Deb Danneman):** The deadline for submission of articles for next month's newsletter is May 12.

Secretary (Ann Chmielewski): No report.

**Service Projects (Cindy Kleve):** Three Guild members cut out more than 200 cancer patient tote bags from donated upholstery-weight fabric. Cindy will check with Fawn to identify a date when Guild members can get together to sew the bags at Project Linus. It is a great opportunity to meet other members while working on one of our service projects. Cindy said that some of the Quilts of Valor were donated to the Eagles Healing Nest, Sauk Centre, for their new women's wing. More kits are available for the Quilts of Valor service project.

**Treasurer (Brooke Strassburg):** The Treasurer's report for March/April was reviewed. A motion was made by Ann and seconded by Marlyn to accept the March/April 2015 Treasurer's Report. Motion passed. Brooke explained that the Quilt Show CD matured in February and was not cashed in during the short window of time before it was automatically renewed for another year. There is a penalty to close the CD now, which is greater than the interest earned in the last year. Since the Guild has a sufficient balance in Savings, Brooke asked if it would be okay to transfer money from Savings to the Quilt Show account instead of cashing in the CD. A motion was made by Marlyn and seconded by Cindy to transfer \$3,000 from Savings to the Quilt Show account. Motion passed.

**Small Groups (Audrey Abraham)**: Audrey mentioned that the  $9\ 1/2$ " scrappy block is the most popular of the two block patterns, so she will discontinue promoting the other block pattern (but will still accept any that are turned in). All of the donated blocks will be sewn into quilts for the service projects. This is the last month for the row-by-row brown bag exchange. Next month the small group members will get their bags back. The row-by-row quilts will be displayed as a group at the quilt show.

**Programs (Marlyn Anderson and Teri Olson):** Marlyn announced that speakers and programs have been arranged through March 2016.

**Quilt Show (Marjorie LaTour):** A quilt appraiser will be available during the quilt show for members who wish to have a quilt appraised. Beth Probasco, the raffle quilt ticket coordinator, made up an envelope for each Guild member containing 20 raffle tickets, a photo of the quilt and information about the quilt. Envelopes will be available for pick up

at the meeting. Additional tickets are available. Tickets will also be sold at the Art Crawl and at Gruber's during the shop hop weekends and the weekend of the Little Falls Arts and Craft Fair. Charlene Fleischhacker, the publicity coordinator, has quilt show postcards and flyers available for members to distribute.

**Membership (Fawn Wright):** Currently, there are 134 paid members for 2015. Board members discussed offering a recruitment incentive to current Guild members. During the months of June, July, August and September, members would receive a coupon worth \$5 off next year's membership fee for each new member that is recruited. This offer is for **new** members only (individuals who have **never before** been a member of SCHQ). A motion was made by Fawn and seconded by Marlyn to offer this recruitment incentive to current Guild members during the months of June, July, August and September. Motion passed.

A motion was made by Sandra and seconded by Audrey to adjourn. Motion passed. The meeting adjourned at 6:15 p.m.
